

Fast Accounting 11 supports in receiving and disbursement related to cash, cash in bank or loans in detail by customers/suppliers, invoices, contracts and fee items.


With a simple click users can view quick reports of balance of cash on hand, cash in bank and loans.




### Accurate purchasing management and timely payment

### Accurate and detailed project/construction management




Fast Accounting tracks projects and construction from expense estimating to calculating cost, profit and account receivable well as account payable.
